

SUMMARY ANNUAL REPORT

For NORTHEAST CARPENTERS ANNUITY FUND

This is a summary of the annual report for Northeast Carpenters Annuity Fund, EIN 22-2406812, Plan No. 002, for period January 2019 through December 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$166,725,144. These expenses included \$8,208,334 in administrative expenses, \$157,810,580 in benefits paid to participants and beneficiaries and \$706,230 in deemed distributions. A total of 38,823 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$2,321,412,113 as of December 2019, compared to \$2,075,817,102 as of January 2019. During the plan year the plan experienced an increase in its net assets of \$245,595,011. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$412,320,155, including employer contributions of \$96,906,151, realized gains of \$81,904,750 from the sale of assets, earnings from investments of \$233,037,697, and other income of \$471,557.

The plan has contracts with Massachusetts Mutual Life Insurance Company, New York Life Insurance Company, Prudential Retirement Insurance and Annuity Company and The Union Labor Life Insurance Company which allocate funds toward individual policies. The total premiums paid for the plan year ending December 2019 were \$10,011.
